## REQUEST FOR BIDS

Oglala Lakota Housing Authority ("OLHA") is requesting cost bids from Propane Vendors for the 2024-2025 **OLHA Elderly Energy Program**. Bids must be sealed with the name of the vendor on the outside of the envelope and be marked "Propane Bid 24-25".

Bids will be requested for a per gallon price for the contract total amount of **145,000 gallons of HD-5 grade propane for residential consumption**. The OLHA Energy program will run from November 1, 2024, to March 31, 2025.

The service areas will be within the exterior boundaries of the Pine Ridge Indian Reservation. There will be three different area designations: Area 1: (west), Area 2: (central), Area 3: (east)

- Area 1: West Section of the Reservation (Pine Ridge, Wakpamni, and Oglala Districts).
- Area 2: Central Section (Wounded Knee, Medicine Root, and Porcupine Districts)
- Area 3: East Area/Section (LaCreek, Eagle Nest, and Pass Creek Districts)
